Legacy Giving - Frequently Asked Questions

What is a legacy gift?

A legacy gift (also called a planned gift or bequest) is a meaningful way to support Meals on Wheels Waco in the future, often through a gift in your will or trust. It allows you to continue caring for local seniors even after your lifetime.



Do I need to be wealthy to leave a legacy?

Absolutely not. Legacy giving is for everyone. Even a small percentage of your estate or a modest gift can make a lasting impact. Many of our supporters are everyday people who simply care deeply about helping others.

What kind of gift can I leave?

Most legacy donors choose to:

- Leave a specific dollar amount
- Leave a percentage of their estate
- Leave what's left (the "residue") after other gifts are made

You can also name Meals on Wheels Waco as a beneficiary of your:

- Retirement plan (like an IRA or 401k)
- Life insurance policy
- Bank account (by using a payable-on-death form)

How do I include Meals on Wheels Waco in my will?

It's as simple as adding a few lines to your will. Here's suggested language you can bring to your attorney or advisor:

"I give to Meals on Wheels Waco, a nonprofit corporation located at 501 West Waco Drive, Waco, Texas, 76707, the sum of \$_____ (or _____% of my estate) to be used for its general purposes."

Can I choose how my gift will be used?

Yes. Most supporters allow us to use legacy gifts where they're needed most, but if you have a specific area you'd like to support (like meals, pet food, or senior center activities), let us know and we'll work with you.
